Resignation of Chief Financial Officer

On May 23, 2023, Mr. Dennis Schemm informed Trex Company, Inc. (the "Company") of his intention to resign from the position of Chief Financial Officer ("CFO"). Mr. Schemm's departure is not due to a conflict or disagreement with the Company or the Company's operations, policies or procedures. Mr. Schemm will continue to serve as CFO until June 9, 2023, at which time Mr. Bryan Fairbanks will assume the responsibilities of the CFO on an interim basis. Mr. Fairbanks served as the Company's CFO from 2015 through April 2020 before he was named President and Chief Executive Officer. The Company has begun the search to identify its next CFO.
